FAMILIES. EACH NIGHT WE PROVIDED TEMPORARY HOUSING FOR 72 FAMILIES AT
ONE OF OUR THREE HOUSES WE OPERATE IN THE VALLEY. WE PROVIDE A
WELCOMING "HOME-AWAY-FROM-HOME" FOR FAMILIES WHICH INCLUDE PRIVATE
GUEST ROOMS AND PRIVATE BATHROOMS. WE HAVE PRIVATE APARTMENTS FOR
FAMILIES WHO HAVE CHILDREN WHO ARE IMMUNOCOMPROMISED. WE PROVIDE
